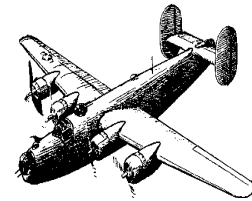

The Virginia Chapter of the 8th Air Force Historical Society met at Stonehenge County Club on 23 October 2010. President Lew Burke called the meeting to order at 1150. Fourteen members and guests attended.

President Burke reported on the Collier Foundation Fly-In at the Warrenton-Fauquier Airport on 10 – 13 October. The fly-in featured a B-17, B-24, and P-51. A veteran's panel, including Luftwaffe pilot Rolf Kohler, was held. He also reported that SAIC sponsored the fly-in and paid for 28 B-17 rides for veterans. He also reported that eight new members joined the Virginia Chapter at the fly-in.

Robert E. Noziglia, Lt. Col., USAF (Ret), born 23 January 1921, in Brooklyn, N.Y., passed away on 10 November 2010, in Alexandria, Va. Col. Noziglia joined the U.S. Army Aviation Cadet Program in 1942. He flew a B-17 bomber in WW II, and C-54 missions in the Berlin Airlift. He then joined the U.S. Air Force, was a B-52H Aircraft Commander and Squadron Commander, and retired with the rank of Lt. Colonel In 1970. After retirement, he moved to Richmond and became the Planning Program Administrator with the Virginia Division of Aeronautics until 1976. He was Past President of the Virginia Chapter of the 8th Air Force Historical Society. He is survived by his wife of 64 years, Mae H. Noziglia of Newport News; sons, Robert E. Jr. of Collierville, Tenn., and Charles David of Alexandria; four grandchildren, Robert, Timothy, Rhea, and Manica; and brother, Harold of Tucson, Ariz. A Funeral Mass was held at Good Shepherd Church in Alexndria on 13 November. He will be buried at Arlington National Cemetery at 3 p.m. on 4 February 2011.
